

# **Individual Narrative of Mary Everett**

#### Mary Everett.1

Mary Everett whose parents are unknown was born between 1650 and 1660. guess. Mary lived in South Carolina between 1682 and 1684. 12

The will of **Thomas Stanyarne** was written on May 10, 1682 in Charles Town, South Carolina, and probated on Feb 14 1683. Heirs: **Jonathan Fitch**, **Jonathan Ladson** and **Edward Mayo**. Each of the three Quakers was left one calf and one heifer. **Mary Everett** was also mentioned in the will but due to the punctuation in the will summary, it is not clear why Mary was listed.<sup>2</sup>

Before 1684, Mary Everett, a Quaker Trustee arrived in the Province of South Carolina.1

Notes for Michael Everett:
1746 July 14 Capt Everett of his Majesty's ship, the Aldborough, plans to sail as soon as the hurricane permits. [252][253]
1746 July 28 Wednesday, his Majesty's ship, commanded by Capt Everitt, attempted to sail over the bar but was obliged to put back. On Friday night as she lay in Rebellion Road, she had upwards of ten men knocked down and her mast to be flattened by lightning, and is obliged to wait for new ones. [252] [253]
1746 Aug 11The Aldborough, Man of War, commanded by Capt Everitt has sailed for Cape Bruton. [252] [253]
1746 Dec 1 Yesterday his Majesty's ship, Aldborough, Michaelf Everitt, Esq, Commander, arrived with a large sloop which he retook the 28th and had been taken by a Spanish Privateer the 15th. This sloop is laden with mahogony plank and ligium vitae, belonged to Meflis. 31 Spaniards were on board. [252] [253]
1746 Dec 15 Thomas Innsy, Esq, is the present Capt of his Majesty's ship and not Capt Everitt as was said in our last. (Dec 8) [252] [253]

# Farmers, Planters, and cord wainers

The first male Everett recorded in South Carolina was Archibald Everett who is recorded in South Carolina in 1713-1715. His exact location in South Carolina is unknown.

There are no Everetts (or Averetts) listed in the South Carolina tax lists for 1733-1742 that exist today.

Beginning in 1744, Everetts were recorded in the interior of South Carolina near the area which is now Columbia, the state capital. This area has been labeled, Craven County, Camden District of Craven County, Richland County of the Camden District, the Richland District and now is Richland County. In addition it was identifed by the Anglican Parish names of Saint James Santee Parish, Prince George Parish, Prince Frederick Parish, and Saint Marks Parish. In the biographies of individuals, I have tried to label the area as it would have been at that particular time. In this summary, it is referred to as Richland Co which is the present designation.

Based on available information, I think that the Everetts of Richland Co SC became the Averetts in Hancock Co and Warren Co GA. "The History of Georgia and Its People", <a href="http://www.archive.org/details/storyofgeorgiage00smituoft">http://www.archive.org/details/storyofgeorgiage00smituoft</a>, states that many of the early Georgia settlers from South Carolina would finish the harvest season in South Carolina then go to Georgia to work on new land they had purchased or were granted. When the growing season began, they would return to South Carolina to grow another crop. It might take several years before the Georgia location was ready for them to move their familes from SC to GA. Thus, they might appear in tax and census records in SC at the same time they appeared in tax lists in Georgia.

Therefore it is possible that some Averetts/Everetts purchased land in Georgia prior to 1790, lived in Richland Co SC in 1790, and moved to Georgia shortly after the 1790 census. The William Averett who lived in Warren Co GA in 1810 still owned land in Richland Co SC.

#### Benjamin

Benjamin Everett #1 is the first Everett recorded in the Camden/Richland area. He helped to appraise an estate in 1744 and in 1755 applied for a land grant stating that he was married and had one child. This is probably the Benjamin Everett whose will was recorded in Richland Co in 1791. Benjamin #2, William #1, and Richard Everett were executors. James Everett is the only son mentioned in the will.

In the 1790 Richland Co census, the only Benjamin is a Benjamin John Everett. Was this Benjamin #1 or Benjamin #2? Why weren't both listed?

Benjamin #2 is probably the Benjamin Averett/Everett that later lived in Hancock and Warren Counties in Georgia. In 1810, Benjamin Averett #2 was asked by William Averett of Warren Co GA to go back to Richland Co and sell some land for him and his wife Judith.

#### Richard

There were 2 Richard Everetts in early SC. A Richard Everitt first appears in 1784 records for Richard Co. There are also several other records for Richard Everitt. Don't know which one is #1 and which is #2.

There are 2 Richard Everitts in the 1790 Richland Co census. Richard #1 is single with no children and 20 slaves. No other Everitts were living near this Richard. Richard #2 is married with children and 4 slaves. A William Everitt was enumerated directly before Richard.

One Richard died in 1791. Based on the estate appraisal, Richard #2 married with 4 slaves died in 1791. Benjamin, William, and John Everett were given letters of administration as administrators since they were the nearest of kin. Their relationship to Richard#2 is unknown.

There was a Richard Everett still living in 1820 in SC. This was probably Richard #1.

#### <u>John</u>

There was a John, a John Albright, a Benjamin John, an Albright, and a Bright/Brite Everett/Everit/Everitt/Averett.

ASSUMPTIONS: It is presently assumed that John and John Albright are the same person; Benjamin John is either Benjamin #1 or Benjamin #2; and Albright, Brite, Bright are the same person.

John first appears in Richland Co records in 1762 and as John Albright in 1768. He appears in the records until 1778 when his estate was appraised. His name is sometimes listed as Averett. He was a cord wainer which means he was a maker of shoes and other goods from fine soft leather.

A John Everett was one of the executors of the estate of Richard Everett#2 in Richland Co SC in 1791.

One of the sources for the records of John Averett of Hancock Co GA lists his name as John A Averett. This John Averett died about 1810 in Hancock Co.

There is also a Revolutionary War record for a John Everett. This is probably John Albright.

# Albright, Brite, Bright

Albright (#1) Everett first appears in the records in 1778 around the time of the death of John Albright Everett. His birth would therefore be 1760 or before. He was usually referred to as Brite or Bright.

There was an Albright Averett who died in Hancock Co GA about 1801. At first glance, one could guess that this was probably the Albright #1 who first appeared in 1778 in SC.

However The Louisville Gazette at the time said that the Albright Averett who died about 1801 was the son of William Averett of Warren Co GA. Louisville was the state capitol of GA and

the Gazette was considered the state newspaper. This would mean that William would have to be at least 15 years older than Albright to be his father which would put his birth as 1745 or before. There is no William Everett/Averett identified in SC until 1788. So it considered likely that the Albright who died in Hancock Co in 1801 would be Albright #2.

Albright #3 was born about 1790. The 1850 census lists his birth as SC. I have concluded that his father was probably Archibald Averett who lived in Warren Co then Hancock Co GA for several reasons. However given the movements of the Averetts/Everetts between SC and GA, Albright #3's birth could be either Georgia or South Carolina.

#### William

There are at least 3 or 4 William Everetts who lived in SC in the late 1700s. Three are in the records for the Richland Co Camden District and one is in the records for the Orangeburg District.

The first record of a William Everett in SC is in the Orangeburg District in 1778. This William Everett is labeled as #1. William Everett #1 died in Winton Co, Orangeburg District, SC in 1788. His sons were Thomas, and John M who was under 21, and his wife was Nancy. Four daughters were listed in his will

DNA testing by Family Tree DNA has identified this line as connected to Nathaniel Everett line. Most of Nathaniel's descendants moved from North Carolina to Georgia without settling in South Carolina.

In the 1790 census for the Orangeburg District, there is an Ann Everett who is the head of a household but no Nancy. Was she Nancy Anne? See Thomas Everett.

No other William Everetts have been identified in Richland Co SC until the 1790 census where there are 2 William Everetts, #2 and #3.

#2 William Everit: males 1 >16, 2<16; 2 females; 1 slave. Enumerated next was Benjamin John Everit with 4 males >16; no females; 12 slaves.

#3 William Everit: males 1>16, 1<16; 3 females; 5 slaves. Benjamin John Everett was enumerated next to this William.

There was a William Averett Sr and a William Jr who lived in Warren Co GA in the early 1800s. William Averett Sr owned land in Richland Co SC and he is identified in one source as the father of the Albright Averett who died in Hancock Co GA in 1800.

It is unknown if William Averett Sr or Jr are either #2 or #3 William Everett in the 1790 Richland Co SC but it is considered likely. #2 William, #3 William, and William Sr were slave owners. Nothing specific is known about William Jr other than he purchased items at the estate sale of Albrite Everett in 1801 in Hancock Co GA.

#### **Thomas**

William #1 who dies in the Orangeburg District in 1788 had a son named Thomas who is labeled as Thomas #1.

There was a Thomas Everett from South Carolina who served in the Revolution. Perhaps this was Thomas #1.

Thomas Everett probably #1 died about 1805 in the Orangeburg District without a will. His estate records identify children as William, John, Benjamin, Alexander Benjamin, Mary, Rebecca, and Elizabeth. No wife is mentioned.

Ann Everett, a widow of Thomas Everett, was re-married by 1808 to John Stallings

These facts could all belong to the same Thomas Everett.

#### **SUMMARY:**

1788 William Everett #1 died in Orangeburg Co SC. sons: Thomas and John M. 1790 Richland Co SC census: 2 Richards, 2 Williams (#2 and #3), 1 Albright, 1 Benjamin John.

#### **South Carolina Everetts in the Revolution**

#### Elijah Averett

1782 Elijah Averett served as a horseman under Capt Vardry McBee and Col Roebuck during 1782.

No other records for an Elijah Averett/Everett by any spelling have been found for SC or GA.

#### John Averitt

1777 July 1 - John Averitt enlisted in the Third Regiment.

Could be John Albright Averett/Everett?

#### **Thomas Everett**

No details available

The will of William Everett who died in 1788 in the Orangeburg District identifies a son named Thomas.

No other records for a Thomas Averett/Everett have been identified in SC records. However than was an Ann Everett, widow of a Thomas Everett, who had married John Stalings by 1808. There was a Ann Everett who was head of a household in 1790 in the Orangeburg District of SC so Thomas probably dies before 1790.

There were no Averetts or Everetts on the South Carolina tax lists for 1733-1742. [240]

Children: In 1755, Benjamin mentions 1 child. His 1791 will mentions several children. It is unknown if any of the children mentioned in his will was the one mentioned in 1755.

1755 Jul 4: The petition of Benjamin Everit humbly setting forth that the petitioner had a wife and one child for whom & himself he never had any warrent or survey or grant of land in this province, prays to lay out one hundred and fifty acres of land near Broad River and that a grant might pass to him for the same. 

BIRTH: One source [218] says that William Averett Sr was the father of the Albright Averett who died in Hancock Co GA in 1800. If this Albright Averett is the Albright Everett who lived in Richland Co SC, he would have to have been born bef 1745 since Albright starts appearing in records in 1778. Question: Why wasn't there a William Everett in Richland Co before the 1790 census? Maybe he wasn't a land owner at that time but had some occupation in Columbia or Albright moved to South Carolina before his father William moved there.

William Averett of 1819 Warren Co GA owned land on Spears Creek in Richland Co SC.[242] It is unknown if he is one of the William Everitt's in the 1790 Richland Co SC census.

Some of the early settlers of Georgia were from South Carolina. After their crops were made in South Carolina, they would come to Georgia, clear land, and built shelters until they were ready to move their families to Georgia. [285]

#### Early South Carolina 1682-1800

It is very difficult to perform research for early South Carolina without understanding counties, districts, and parishes. The Everetts/Averetts of early South Carolina were primarily located in two districts: Camden District and Richland County, and the Orangeburg District and Winton County and Barwell Counties. 	1682 Original 3 proprietary counties of SC were formed along the Atlantic coast.
	From northeast to southwest, they were Craven, Berkely, and Colleton.
	1685 Carteret Co was formed along the coast as the most southern county.
	1706 Most of the area known as South Carolina was divided into 10 parishes of the
	Anglican Church.
	1731 Prior to this time, all geographical named areas were along the coast. In
	1731, townships were established in the interior of the state.
	In 1733, several county lines were extended into the interior with no interior boundaries. This included Craven and Granville Counties.
	In 1768 as more of the inland region was settled, the citizens of South Carolina decided that
	they needed a more centrally located capitol instead of Charlestown. So they purchased land

1791 the counties within the Orangeburg District were de-organized. As a result, the Orangeburg District was no longer divided into counties.
1800 the Orangeburg District became the Orangeburg and Barnwell Districts with Barnwell being along the Savannah River and Orangeburg being to its northeast.
1868 The Orangeburg District and the Barnwell District were redesignated as Orangeburg County and Barnwell County.
